10 The parties by and through their respective counsel stipulate as follows:

11 **A. Main Appeal - Supreme Court Case No. 79917.**

12 Nanyah Vegas, LLC v. Sig Rogich, et al. This is the initial Appeal in this
13 matter and stems from the District Court's various decisions dismissing Nanyah
14 Vegas, LLC's claims in total (the "Main Appeal"). The briefing schedule in the
15 Main Appeal was suspending pursuant to the Court's March 16, 2020, Order to
16 Show Cause. The parties filed their separate responses to the Court's Order to
17 Show Cause on April 15, 2020. In addition, Nanyah Vegas, LLC ("Nanyah"),
18 filed a Supplement to its response on April 28, 2020. The Court has not yet issued
19 a renewed briefing schedule in the Main Appeal.

20 **B. Eliades Fee Appeal - Supreme Court Case No. 81038.**

21 Nanyah Vegas, LLC v. Sig Rogich, et al. This is the Appeal of the District
22 Court's granting an award of attorneys' fees in favor of Peter Eliades and TELD,

1 LLC, a Nevada limited liability company (the "Eliades Fee Appeal"). Currently
2 Nanyah's opening brief and appendix are due in the Eliades Appeal on or before
3 August 21, 2020.

5 **C. Omnibus Fee Appeal - Supreme Court Case No. 81238.**

6 Nanyah Vegas, LLC v. Sig Rogich, et al. This is the Appeal of the District
7 Court's granting an award of attorneys' fees and/or costs in favor (1) Peter Eliades
8 and TELD, LLC, a Nevada limited liability company; (2) Peter Eliades, The
9 Eliades Survivor Trust of 10/30/08; TELD, LLC and Eldorado Hills, LLC; and (3)
10 Sigmund Rogich, individually and as Trustee of the Rogich Family Irrevocable
11 Trust and Imitations, LLC (the "Omnibus Fee Appeal"). Currently Nanyah's
12 opening brief and appendix are due in the Omnibus Fee Appeal on or before
13 September 30, 2020.

17 **D. CONSOLIDATION.**

18 The parties agree that Supreme Court Cases 79917, 81038 and 81238 should
19 be consolidated for all further proceedings. Further, the parties stipulate to
20 consolidate the briefing based upon the Main Appeal. The parties believe that
21 consolidation will minimize the consumption of judicial resources, the resources of
22 the parties and will yield the most expeditious resolution of the claims in these
23 matters. The Court is therefore, requested to consolidate the three cases stated
24 herein based upon this stipulation. Upon the Court entering its order consolidating

2 further requested that the consolidated matter proceed under Case No. 79917.


