**STIPULATION TO CONSOLIDATE APPEALS AND
EXTENSION OF TIME TO FILE OPENING BRIEF**

Pursuant to NRAP 3, Titina Farris and Patrick Farris, Respondents/Cross-Appellants in Case No. 80271 and Respondents in Case No. 81052 (“Respondents”), and Barry James Rives, M.D., and Laparoscopic Surgery of Nevada, LLC, Appellants/Cross-Respondents in Case No. 80271 and Appellants in Case No. 81052 (“Appellants”), by and through their undersigned attorneys, hereby stipulate that Case Nos. 80271 and 81052 be consolidated into one appeal.
