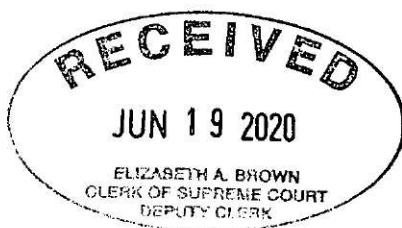

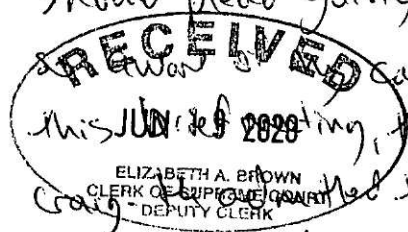

I, Baron Jones, with pure intentions, state that the following is true and correct to the best of my ability under penalty of perjury:

1. At STEIN (SNAMHS) a staff member, named Beverly, had me take a legal competency test; at my prompting through Dr. Abu Kamil. On or about June 9, 2020, I caused Beverly to disclose my test results to my treatment team. After the treatment team meeting, Beverly informed me that I got 100% on the legal competency test. At treatment team, Dr. Leah Foley, said she would contact my attorney, Christine Craig (I failed to remind her about her earlier promise to call her). In the treatment team they were asking me questions regarding the charges that were adversarial in nature; I felt I should have had an attorney present with the barrage of interrogating questions.
2. On or about June 11, 2020, at or around 1-3pm, Dr. Abu Kamil went over my Criminal charges (in Case No 20F06160) with me; when I told him I never took a positive test approved by the State Board of Health, he said the police might have subpoenaed my discharge notes from my doctor at Seven Hills (he said they do that sometimes), and by my signature being on the bottom of the discharge notes where it list my illness (he said), he said I should plead guilty. I found this quite peculiar for him to be saying this now, more than me. He later disclosed during this meeting, that he has been in contact with my attorney, Christine Craig, and that he failed to mention to her why she has not contacted me; which I found to be troubling because I brought



his concern to his attention numerous times; and even the treatment team meetings. It should be noted that he tried to persuade me to plead guilty, several times during this exchange; and tried to put me on pschic meds again. Every time I meet him that's all he wants to talk about is putting me on pschic meds. On retrospect, I find it troubling that he is constantly trying to push meds upon me; and now trying to persuade me to plead guilty.

3. I am, I believe, being submitted to abuse by being denied continued access to my attorney by Dr. AbuKamil and my case worker, Lisa; they are both aware of how my attorney Craig has not been in contact with me since March 31, 2020; but both of them are. Furthermore, I am being submitted to abuse because I have not had access to confidential/legal calls because they have been monitored by staff and I have been reprimanded by staff for my complaint/grievances to outside agencies because the staff were listening.

4. Also, they want SevenHills medical reports on me, really bad here. Like an obsession. I do not know why. I believe fraud may be apparent or in the process. I was compelled to sign a Release of Information form, by Lisa, my case worker. She said if I did not sign, Dr. AbuKamil would sign on my behalf. I am afraid for my life, liberty, and freedom here at STEIN. Please Help Me Posthaste.
