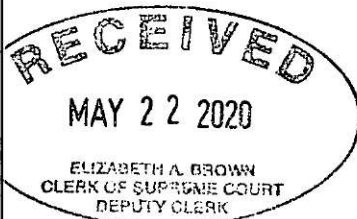

9                   **PETITION**

10           The Board of Governors of the State Bar of Nevada (State Bar) hereby  
11 petitions this Court to enter an Order declaring June 24, 2020 the annual meeting,  
12 as required under Supreme Court Rule (SCR) 94.

13           Due to concerns for the health and safety of attendees, the State Bar canceled  
14 the annual convention scheduled for June 25-27, 2020 in New Orleans, Louisiana  
15 at which the annual meeting was scheduled. Court Rules require the Board of  
16 Governors to conduct an annual meeting between January 1 and December 1 of  
17 each year, with thirty active members of the bar constituting a quorum, and notice  
18 of the meeting mailed to members at least 30 days prior to such a meeting. The  
19 Court Rule also requires the Board of Governors to provide a suitable program for  
20 each annual meeting to assure participation by a broad spectrum of the bar. The  
21 State Bar seeks relief from the requirements imposed under SCR 94 for the 2020  
22 calendar year.

23           Additionally, Court Rules regarding the election of Board of Governors (SCR  
24 82, 83 and 84) have timelines associated with the annual meeting In consideration


1 of these timelines and the 2020 election, the State Bar submits this Petition setting  
2 June 24, 2020 as the date of the annual meeting to conform with Court Rules.

3 The State Bar shall provide Notice to all members that they are invited to  
4 participate in the annual meeting via electronic format and designated log-in will  
5 be provided for all members that register to attend.

6 Based upon the above, the Board of Governors requests that the Court  
7 approve this Petition seeking (1) approval of June 24, 2020 to be deemed as the  
8 designated annual meeting for 2020 as mandated under SCR 94; and (2) that the  
9 requirements for a quorum, meeting notice, suitable programing, and other  
10 mandates for the annual meeting as set forth in the Supreme Court Rules be waived  
11 for the 2020 annual meeting.
