Respondents TIMOTHY LEE BAILEY & CONSTANCE MARIE BAILEY and FRED BAILEY & CAROLYN BAILEY (collectively, the "Baileys" or "Bailey Respondents"), by and through their undersigned counsel of record, hereby file this Notice of their Intent to Oppose DNRPCA Appellants' Emergency Motion for Stay Pending Appeal.

The Baileys oppose a stay of the district court's order granting the Baileys' petition for judicial review because the requested stay would reinstate the illegal Diamond Valley Groundwater Management Plan. As will be shown in the Baileys' forthcoming opposition to the Motion, and as already determined by the district court in denying the DNRPCA's motion to stay filed therein, it is the Baileys, and not the Appellants, who will suffer irreparable harm should the Groundwater Management Plan be reinstated for the duration of this appeal.

DNRPCA Appellants have requested that this Court issue an order on the Emergency Motion by July 10, 2020. The only argument presented in support of *emergency* relief is based on DNRPCA's incorrect assumption that the 30-day automatic stay of enforcement of a judgment pursuant to NRCP 62(a)(1) applies to the district court's order overturning the Groundwater Management Plan. But NRCP 62(a)(1) does not apply to the district court's order, that order went into effect immediately upon its issuance.

The Baileys respectfully suggest that no emergency circumstances exist that require shortening the time for responses to the Motion. The Baileys request that the Court provide reasonable opportunity for the Baileys and other respondents to file oppositions to the Motion, of 7 calendar days, to and including July 14, 2020.
