## ORDER GRANTING MOTIONS TO MODIFY CAPTION AND TO EXCEED PAGE LIMIT

This is an appeal from a district court order granting a petition for judicial review in a water law matter and reversing State Engineer Order 1302, which approved the Diamond Valley Groundwater Management Plan. Appellants Diamond Natural Resources Protection & Conversation Association and others (collectively, DNRPCA appellants), along with the State Engineer and Eureka County, have filed a joint motion to modify the caption to more accurately reflect the parties' status as appellants, not cross-appellants. The unopposed motion is granted; the clerk of this court shall modify this docket's caption to conform to the caption on this order.

The DNRPCA appellants have also filed a motion for leave to file an emergency motion for stay in excess of the NRAP 27(d)(2) page limit. Respondents have filed notices of intent to oppose both motions. Nevertheless, the motion for leave to file a stay motion with excess pages is granted; the emergency stay motion was filed on July 6, 2020. Any oppositions to the stay motion are due on or before July 13, 2020.
