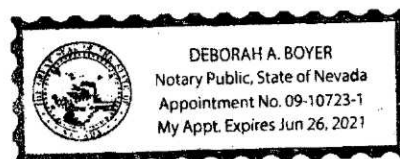
10 2. That this request was electronically filed on September 30th, 2019, and that the
