

ORDER GRANTING MOTION

Appellants have filed a motion to associate attorney Robert Gall of the Institute for Justice pursuant to SCR 42. Attached to the motion to associate is a verified application for the attorney, a certificate of good standing from the Supreme Court of North Carolina, a certificate of good standing from the Supreme Court of Texas, a certificate of good standing from the District of Columbia Court of Appeals, and a Supreme Court Rule

42 statement. The application and the Rule 42 statement of the State Bar of Nevada indicate that Mr. Gall has not applied to appear in Nevada courts within the past three years. *See* SCR 42(6) (repeated appearances by any person or firm pursuant to this rule shall be cause for denial of a motion). The motion is granted. Mr. Gall shall be permitted to appear on behalf of appellants. Nevada attorney Joshua A. House of the Institute for Justice shall be responsible for all matters presented by Mr. Gall in this matter. *See* SCR 42(14); NRAP 25(a)(5) (all documents submitted to the supreme court for filing by a represented party shall include the original signature of at least one attorney of record who is an active member of the State Bar of Nevada).
