**MOTION FOR EXTENSION OF TIME  
TO ANSWER PETITION FOR REHEARING**

Respondents National Union Fire Insurance Company of Pittsburgh, PA and Roof Deck Entertainment LLC d/b/a Marquee Nightclub request a 30-day extension through March 15, 2023, in which to file their answer to appellant's petition. NRAP 26(b)(1)(A)). This is the second request. The original deadline of January 12, 2023 was extended to February 13, 2023.

Good cause necessitates the extension. The answer requires close coordination among appellate counsel, trial counsel, and their clients. Counsel have prepared a draft of the answer, but lead appellate counsel needs additional time to review and comment following his return after
