
## **FACTS**

Appellant herein requests the court allow him an extension of time to file his REQUEST FOR TRANSCRIPT; DOCKETING STATEMENT and APPELLANT'S PRO SE CHILD CUSTODY FAST TRACK STATEMENT. He is not sure of the deadlines, as mail was originally sent to an old address. He called the Appellate Court, who provided him the documents to his proper address.

Appellant provides herewith said Request for Transcripts, and Docketing Statement; however, he believes it may have taken him longer than the provided time to prepare such documents. Appellant is in Proper Person, and he needed additional time to prepare each documents - especially with the issues surrounding COVID19. It is harder to obtain any assistance and get documents from the courthouse. 
