MOTION FOR EXTENSION OF TIME FOR OPENING BRIEF AND APPENDIX

(Second Request)

Appellant hereby moves for a 30-day extension of time for filing the opening brief and the appendix. The brief is presently due for filing on April 9, 2021. Therefore, appellant requests an extension until May 8, 2021. This is appellant's second requestion for an extension for the opening brief.

This appeal involves domestication of a foreign judgment. The factual situation and the legal issues (which include constitutional issues) are somewhat unusual. The undersigned counsel associated into the case as appellate counsel after the briefing schedule had already been reinstated.
