**MOTION FOR EXTENSION OF TIME

Appellants Trudi Lee Lytle and John Allen Lytle, Trustees of the Lytle Trust request an extension of ten days, through Monday, November 30, 2020, to file their opposition to Respondents' Motion to Dismiss. NRAP 26(b)(1)(A). The opposition currently is due on November 19, 2020. The original deadline of November 5, 2020 was

continued by grant of a telephonic extension. NRAP 26(b)(1)(B). No extensions have been denied or denied in part.
