**UNOPPOSED MOTION FOR EXTENSION
TO FILE OPENING BRIEF AND APPENDIX**

Appellants Trudi Lee Lytle and John Allen Lytle, as trustees of the Lytle Trust, request an extension of one week, through March 12, 2021, to file their opening brief and appendix. Without this extension, the brief would be due on March 5, 2021. The deadline previously was extended three times pursuant to NRAP 31(b)(3). The parties also stipulated to extend the deadline under NRAP 31(b)(2) from its original

date of November 2, 2020. No requests for extension have been denied or denied in part.

The brief is nearly complete but extraordinary circumstances and extreme need compel appellant to request an additional week.
