forma pauperis status in the district court.

9. *Date proceeding commenced in the District Court:* The guardianship case commenced September 19, 2019.

10. *Brief description of the nature of the action and result in the District Court:* The Court held a hearing on May 20, 2020 to consider Gerry’s petition to remove Kimberly Jones (“Kimberly”) as the Protected Person’s guardian and to require Kimberly to return the Protected Person’s property. Gerry argued that Kimberly should be removed for several reasons, including because the guardianship compliance investigator’s report identified property Kimberly had taken from the Protected Person and had not returned or explained. Gerry asked to be the guardian of the Protected Person, his wife, or for the district court to make specific findings as to why it would not honor the preference granted to a spouse in the guardianship statute. However, during the hearing, the Court summarily denied the petition in its entirety, without making any findings of fact or conclusions of law and without allowing the parties to present any evidence. On May 29, 2020, the Court entered a written order denying the petition in its entirety. Gerry is appealing the May 29, 2020 order.
