7 Appellant Rodney Gerald Yeoman (“Gerry”) by and through his counsel of
8 record does hereby file this Motion for Extension of Time Regarding Substitution
9 of a Personal Representative. This motion is brought pursuant to N.R.A.P. 31.

10 An order was entered herein on September 25, 2020 requiring a motion for
11 substitution of a personal representative be filed within 90 days. That 90 days
12 expires today.

13 No personal representative has yet been ordered by the probate court, and
14 thus the motion for substitution of a personal representative cannot yet be filed.

15 A Petition to Appoint Special Administrator and for Issuance of Letters of
16 Special Administration related to Gerry is currently on calendar for January 8,
17 2021, in Clark County Nevada probate court.

18 No previous extensions for filing of the motion for substitution have been
19 obtained by Gerry, including no 14-day telephonic extensions.

20 No previous requests for extensions by Gerry have been denied.

21 Gerry requests a 30-day extension, beyond the January 8, 2021 probate
22 hearing date, to file the motion for substitution.
