# MOTION FOR EXTENSION TO FILE AMICUS BRIEF IN SUPPORT OF *EN BANC* RECONSIDERATION

Proposed amici Laurent Hallier, Panorama Towers I, LLC,

Panorama Towers I Mezz, LLC, and M.J. Dean Construction, Inc. request an extension through January 5, 2022 to file its brief in support of the petition for *en banc* reconsideration, filed November 29, 2011. NRAP

29(f). Amici also ask that this Court defer ruling on the petition until the filing of that petition. This is the first such request. Without an extension, the brief would be due December 6, 2021.

Good cause warrants the additional time. The panel's decision in this case is closely tied to and served as precedent in the *en banc* Court's opinion in amici's appeal, *Panorama Towers Condo. Ass'n v. Hallier*, 137 Nev., Adv. Op. 67, \_\_\_ P.3d \_\_\_ (Nov. 10, 2021) (Dkt. No. 80615), in which the Court assumed the validity and applicability of AB 421's retroactivity provision and treated it as a change in the law and that should have been applied in a post-judgment motion under NRCP 59(e). The briefs in that *Panorama Towers* appeal also addressed extensively the merits of AB 421, including its applicability and constitutionality, and cited authorities and arguments different from those briefed and considered in this *Dekker/Perich/Sabatini* writ petition.

This Court has regularly allowed the appearance of amici on rehearing or *en banc* reconsideration. *See Powers v. United Services Auto. Ass'n*, 115 Nev. 38, 41 & n.2, 979 P.2d 1286, 1288 & n.2 (1999) (granting appearance of amici on rehearing); *Bahena v. Goodyear Tire & Rubber Co.*, 126 Nev. 606, 608, 245 P.3d 1182, 1184 (2010) (same).

In light of the close relationship between that case and this one, amici submit that their perspective of the underlying issues would be valuable. They wish to see this case finally resolved by the *en banc* court before determining its application in the *Panorama Towers* appeal. If the panel opinion in this writ petition is vacated, the decision in the *Panorama Towers* case predicated upon the panel opinion here must be reevaluated, as well. Amici have requested a similar extension of time to file their petition for rehearing in the *Panorama Towers* appeal.

In addition, respondents' appellate counsel has had to take significant time away from this matter to deal with medical issues involving counsel's newborn son. The attorneys who ordinarily would have worked on this amicus brief have been under extraordinary pressures dealing with a trial which unexpectedly has continued past the Thanksgiving holiday and is now expected to conclude later this week. Amici's lead appellate counsel has also had to take time preparing for an oral argument before this Court on December 7, 2021.

Amici appreciate the parties' and this Court's courtesy in considering the requested extension. The requested extension will enable

the important issues in both cases to be streamline and present for the *en* banc Court's review.
