

**ORDER GRANTING MOTIONS**

The unopposed motion of Laurent Hallier, Panorama Towers I, LLC, Panorama Towers I Mezz, LLC, and M.J. Dean Construction, Inc. for leave to file a brief of amicus curiae in support of the petition for en banc reconsideration is granted. NRAP 29. The amicus brief was filed on January 28, 2022.

The parties have also filed a stipulation for an extension of time for real party in interest to file its answer to the petition for en banc reconsideration. The stipulation is treated and granted as a joint motion because it is not signed by counsel of record for all parties.<sup>1</sup> NRAP 26(b)(1)(A). Real party in interest shall have until March 21, 2022, to file and serve its answer to the petition for en banc reconsideration. Real party in interest shall include any response to the amicus brief in its answer.
