(First Request)

Respondent/Cross-Appellant, Wendy Jaksick (“Wendy”), by and through her counsel of record, Marquis Aurbach Coffing and Spencer & Johnson, PLLC; Appellant/Cross-Respondents (1) Michael S. Kimmel, individually and as Co-Trustee of the Samuel S. Jaksick Jr. Family Trust, (2) Todd B. Jaksick, Co-Trustee of the Samuel S. Jaksick Jr. Family Trust and Trustee of SSJ’s Issue Trust, and (3) Kevin Riley, individually, as former Trustee of the Samuel S. Jaksick Jr. Family Trust, and as Trustee of the Wendy A. 1. The current filing deadline for Wendy's Answering Brief on Appeal/Opening Brief on Cross-Appeal is currently due on May 13, 2021. Wendy, the Trustees, Todd, and Stanley hereby stipulate and agree that the new filing deadline for Wendy's Answering Brief on Appeal/Opening Brief on Cross-Appeal shall be due on June 14, 2021. 2.
