1 MEMORANDUM OF POINTS AND AUTHORITIES

2
3 I. Nature of Motion:

4
5 Through the instant Motion the Appellant
6 seeks the withdrawal of Court appointed Appellate
7 Counsel, appointed by the District Court on
8 August 26, 2020, pursuant to this Courts Order of
9 Limited Remand For Designation of Counsel.

11 II. Argument:

12
13 The Appellant does not desire to be
14 represented in the instant appeal by counsel, and
15 he wishes to proceed on appeal in proper person,
16 thus he request that this Court withdraw Court
17 appointed appellate counsel, allowing him to
18 proceed in his proper person in the instant
19 appeal.

20 The Appellant identifies that he has not
21 requested that Appellant Counsel be appointed to
22 represent him in proceedings before this Court,
23 and that he desires to proceed as an unrepresented
24 litigant in the instant appeal. Thus, he refuses
25 the agency of any attorney to represent him in
26 the instant proceedings. The Appellant informs
27 the Court that he has, prior to the appointment
28 of Appellant Counsel, already filed in this Court

1 his proper person Appellant's Opening Brief
2 pursuant to NRAP Rule 28(a). The Appellant has
3 filed and been granted a Motion For Transcripts At
4 Public Expense relative to the July 7, 2020
5 Resentencing Hearing, which had resulted in the
6 July 8, 2020 entry of a new (second) Judgment of
7 Conviction, in Second Judicial District Court, Case
8 NO: CR96-1581. Such Judgment of Conviction of which
9 the Appellant now appeals from through the instant
10 appeal.

11 The Appellant submits that the issues involved
12 in the instant appeal are not particularly
13 complex and are they numerous. Therefore, the
14 Appellant submits that counsel is not necessary
15 in these proceedings. As the Appellant has been
16 self represented through the prior proceedings
17 in the district court, and in prior proceedings
18 in the Nevada Court of Appeals, in Case Nos 74227,
19 which had precipitated the resentencing proceedings
20 in the district court now being appealed from
21 in the instant appeal. The Appellant further
22 informs the Court that he has previously been
23 canvassed by the District Court, pursuant to
24 Supreme Court Rule 253, and was found competent
25 to represent himself in the context of the
26 Proceedings in the District Court. Thus, said Court
27 had granted his proper person status in these
28 proceedings.

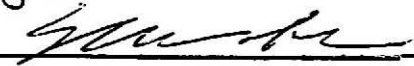
1 III. Conclusion:
