9 **MOTION FOR EXTENSION OF TIME**

10 The opening brief and appendix are due to be filed in this matter on
11 January 25, 2021, pursuant to a previously-granted telephonic extension. The
12 original due date was January 11, 2021.

14 As the court is aware, this matter arises from a conviction that was
15 originally entered in 1996, and post-conviction proceedings that were conducted in
16 2001. In those post-conviction proceedings, the district court ordered a new
17 sentencing hearing, which was not conducted until this court granted appellant's
18 petition for extraordinary relief and ordered a new sentencing hearing. *Order*
19 *Granting Petition*, Docket No. 74227 (August 15, 2018). The instant appeal is
20 from the new judgment of conviction entered on July 8, 2020, pursuant to this
21 court's order, and the pre-sentencing orders entered by the district court on July 7,
22 2020.

23 Despite diligent efforts, undersigned counsel has had some difficulty
24 in obtaining copies of the post-conviction documents from 2001. Those

1 documents are germane to appellant's arguments on appeal and necessary for
2 inclusion in the appendix. Undersigned counsel has been in communication with
3 the district court staff and hopes to obtain access to the necessary documents by
4 next week, but not before the deadline for filing the opening brief and appendix.

7 Based on the foregoing, counsel requests a 30-day extension of time
8 in which to file the opening brief and appendix, until February 24, 2021.
