For the conviction of Count 1, Trafficking in a Schedule 1 Controlled Substance, a Category A Felony as defined by NRS 453.3385.1(c), Defendant is sentenced to a maximum term of 120 months in the Nevada Department of Corrections with minimum parole eligibility after 48 months. Defendant is credited with 655 days heretofore served as computed to and including the date of this sentencing (the 8<sup>th</sup> day of June, 2020). Said sentence shall be served consecutively with the sentence imposed in Case No. CR-FP-17-5748.

For the conviction of Count 2, Possession of a Firearm by a Prohibited Person, a Category B Felony as defined by NRS 202.360.1, Defendant is sentenced to a maximum term of 48 months in the Nevada Department of Corrections with minimum parole eligibility after 12 months. Defendant is credited with 655 days heretofore served as computed to and including the date of the sentencing (the 8<sup>th</sup> day of June, 2020). Said sentence shall be served concurrently with the sentence imposed for Count 1 in the matter, and consecutively with the sentence imposed in Case No. CR-FP-17-5748.

b. The sentence is not stayed pending appeal.

c. The defendant was not admitted to bail pending appeal.


