APPELLANT OELLA RIDGE TRUST'S MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF

Pursuant to Rules 26(b)(1)(B), 27, and 31(b)(3) of the Nevada Rules of Appellate Procedure, Appellant, Oella Ridge Trust ("Trust") respectfully files this motion for an extension of time of thirty days (30) to file its opening brief after the current deadline of February 26, 2021. In accordance with NRAP 31(b)(3)(A), Trust submits the following information:

- (1) Trust's opening brief is due on February 26, 2021.
- (2) The original deadline for the opening brief was January 26, 2021.
- (3) Trust was previously granted a 30-day extension by stipulation to January 26, 2021.
  - (4) Trust has not been denied any previous requests for extensions.

- (5) As the Court is aware, the Governor announced a statewide closure of all nonessential businesses on March 17, 2020. This closure caused substantial disruption to Trust's business. Trust's ability to complete and file the brief has been and continues to be significantly disrupted in an effort to comply with the mandate and adequately comply with the ongoing shutdown.
- (6) Furthermore, Counsel for Defendant had a complete computer crash on Wednesday night, February 3, 2021 which resulted in him being unable to boot up his computer. On Thursday, February 4, 2021, Counsel took his computer to his computer repair expert in order to try and remedy the problem. Unfortunately he was informed that the computer had apparently received a fatal power surge and the expert was unable to revive the computer. This resulted in Counsel having to have an entirely new computer build for him which was received on Monday, February 8, 2021.
- (7) Counsel's computer expert attempted to recover Counsel's data from the old computer but was unsuccessful and had to send Counsel's drive to California to a data recovery company to attempt recovery. Counsel was informed IF they could recover any data, which was not guaranteed, it would take a week to ten days. On February 16, 2021, Counsel received the recovered data drive from California and was able to load all his data back on his computer. This created additional issues completing the opening brief.

- (8) Trust respectfully requests a thirty-day extension until **March 29, 2021**.

  Trust does not anticipate the need for any further extensions.
- (9) The January 26, 2021 Issued Notice of this Court provides that "No further extensions of time shall be permitted, except upon motion clearly demonstrating good cause." Trust respectfully submits that the unprecedented shutdown and disruptions as well as the unexpected computer issues over the past year constitute such good cause.
- (8) This request is made in good faith and not intended to cause delay or prejudice to any party.
