**UNOPPOSED MOTION TO

(SECOND REQUEST)

Respondent SFR Investments Pool 1, LLC ("SFR") respectfully requests an additional thirty (30) days, up to and including **Wednesday, April 21, 2021**, in which to file its answering brief. NRAP 26(b)(1). The brief is currently due on March 22, 2021, pursuant to this Court's February 17, 2021 Order granting the parties' stipulation to extend the time for SFR to file its answering brief. This is the second request to extend time for this brief.

SFR has been diligently working on the brief. However, difficulties relating to the COVID-19 pandemic and the fact that several of SFR's attorneys have been out of the office recently due to personal, family, and medical issues, has required
