The Court further finds that Plaintiffs were not substantially prejudiced by the Court's decision to preclude Dr. Wiencek from testifying.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Court finds that it may have erred in allowing the impeachment of Dr. Marmureanu using the article titled "CA Hits Nerve By Singling Out Cardiac Surgeon with Higher Patient Death Rates," and corresponding State of California report upon which the article is based. However, the Court finds that any potential error in allowing the impeachment of Dr. Marmureanu did not substantially prejudice Plaintiffs in their right to a fair trial.

At the end of the day, Court's ULTIMATE DETERMINATION is that there wasn't really any necessity for lack of a better word for Dr. Weincet to testify. All of his records that were relevant to the case had been well vetted throughout the course of the Pltf's. presentation. That there had been potentially some dispute as to obviously what his records may show or may have illustrated related to the care given on December 25th at the hospital in the emergency room but at the end of the day the Court felt strongly, and again this is the Court's discretion in making this call and why Court still feels It made the right decision at the time, that bringing in Dr. Weincet would not have clarified anything further but might have very well created confusion as to which doctors were on trial; which doctor and nurse practitioner was on trial and which was not. On the grounds whether the Court erred in allowing a discussion of an article from the State of California identifying Dr. Marmureanu, the doctor when he was confronted in cross-examination with this article by Mr Weaver and how he was portrayed in this article; how it portrayed as him being one of the worst doctors of his type in California. Really we have a wash whether if at the time the article was presented correctly by Mr. Weaver or Dr. Marmureanu. At the end of the day COURT FINDS it is likely an Appellate Court reviewing the Court's efforts in this regard would FIND that the Court erred. Court can see where by the argument provided by Mr. Arntz and summation argument by Mr. Hymanson when we were here last week that it is possible that it could be determined that allowing the article to be discussed at the time was in error. There is some argument that the objection was only to foundation and that the objection is not broader in scope as to whether or not it was relevant, whether or not it was improper impeachment, or other potential arguments that were made. Court does believe it was clear Pltf. was objection to the use of the article and to the way in which Dr. Marmureanu was being portrayed in the argument. Court can see how it could be determined the Court erred in allowing this line of inquiry whether it was because the article had not previously been disclosed. Even if accounting for the potential that the Court did error it is still in this COURT'S DETERMINATION still no something rising to the level of requiring a new trail. That ULTIMATELY again for the new trial to be warranted it has to have substantially affected the material rights of the moving party or as cited in the case law to find that it substantially prejudiced the party. Obviously the Nevada Supreme Court will review Court's decision whether to admit or exclude evidence for abuse of discretion, it doesn't change those determinations. For the Court to find a new trial to be granted it must find that it materially affected the rights of the moving party substantially, that is where the Court can't to the extent of granting a new trial. COURT STATED FURTHER FINDINGS regarding who the jury did or did not believe and whose testimony they gave weight to. Court respects the decision that It's decision would be challenged.
