**UNOPPOSED MOTION FOR EXTENSION OF TIME  
TO FILE ANSWERING BRIEF**

Respondent United Automobile Insurance Company (UAIC) requests an extension of 30 days, through June 18, 2021, to file its answering brief. NRAP 31(b)(2). The brief would otherwise be due May 19, 2021. This is the first such motion. UAIC and appellant Cheyenne Nalder previously stipulated to an extension before the consolidation of the appeals and the filing of appellant Gary Lewis's opening brief.

appreciated.

The requested extension is necessary. The attorney primarily responsible for drafting the brief has had to take time away dealing with a family emergency due a serious complication in his wife's pregnancy.
