**MOTION FOR EXTENSION OF TIME
TO FILE ANSWERING BRIEF**

Respondent United Automobile Insurance Company (UAIC) requests an extension of 30 days, through July 19, 2021, to file its answering brief. NRAP 31(b)(2).
