**MOTION FOR EXTENSION OF TIME  
TO RESPOND TO GARY LEWIS’S MOTION  
TO STRIKE AND MOTION TO ENLARGE THE RECORD**

Respondent United Automobile Insurance Company (UAIC)

requests an extension of 30 days, through November 22, 2021, to file its responses to Gary Lewis’s (1) Motion to Strike (Doc. 2021-29747) and (2) Motion to Enlarge the Record (Doc. 2021-29749). NRAP 26(b)(1)(A). The opposition is currently due on October 22, 2021. This is the first such request.

The requested extension is necessary. Lead appellate counsel is in

trial and has had to juggle multiple hearings during breaks, detracting from his ability to address the motions. Counsel's partner, Abraham Smith, would typically assist, but is out on paternity leave. Mr. Smith had to take leave earlier than expected following complications in his wife's pregnancy. This is in addition to another appellate attorney's continued need to dedicate time to managing the affairs of his elderly mother.
