ORDER REINSTATING BRIEFING

On April 8, 2021, this court entered an order partially dismissing these appeals. Appellant filed for rehearing and then for en banc

reconsideration of that order. Briefing was suspended. The petition for en banc reconsideration was denied on November 18, 2021; accordingly, briefing is reinstated as follows. Appellant shall have 28, days from the date of this order to file and serve an opening brief that complies with NRAP 28 and NRAP 32, or an informal brief for pro se parties. Appellant may only challenge the judgment and order with respect to case number A-18-776375-C. Respondents need not file an answering brief unless directed to do so by this court. NRAP 46A(c). Failure to comply timely with this order may result in the imposition of sanctions, including the dismissal of these appeals.

Appellant has filed a response to this court's modification of the caption for these appeals requesting that this court add "A/D/B/A VIP INTERNATIONAL" after "A/D/B/A TLC VACATIONS," and "A/K/A ANGEL SANTILLI" after "A/K/A ANGEL C. MULLIS." No response has been filed. The clerk of this court shall add "A/K/A ANGEL SANTILLI" after "A/K/A ANGEL C. MULLIS." No entity listed in the caption is called "A/D/B/A TLC VACATIONS;" accordingly, the caption shall otherwise remain the same.

It is so ORDERED.
