The Nevada Justice Association ("NJA") files this motion seeking leave of

this Court to file a proposed amicus curiae brief. This motion is made pursuant to

NRAP 29(c) and is based upon the following:

AMICUS INTEREST AND REASONS FOR FILING THE BRIEF

NJA is a non-profit organization of independent lawyers in the State of Nevada who represent consumers and share the common goal of improving the civil justice system. NJA seeks to ensure that access to the courts by Nevadans is not diminished. NJA also works to advance the science of jurisprudence, to promote the administration of justice for the public good, and to uphold the honor and dignity of the legal profession.

Through its proposed amicus curiae brief, NJA seeks to provide this Court with the broader context regarding mandatory arbitration clauses and the specific requirements and rationale of NRS 597.995, as well as the vital Constitutional issues at stake here. Comm'r of Labor & Indus.*, 694 F.2d 203, 204 (9th Cir. 1982) (indicating that the classic role of an amicus curiae is to assist in cases of general public interest and to supplement the efforts of counsel by drawing the Court's attention to law that may have escaped consideration).

Accordingly, NJA respectfully requests leave to file the proposed amicus curiae brief.
