LAWYERS' AMICUS CURIAE BRIEF IN SUPPORT OF REVERSAL
OF THE COURT OF APPEALS DECISION**

The Family Law Section of the State Bar of Nevada (“FLS”) hereby joins the “Amicus Curiae Brief in Support of Reversal of the Court of Appeals Decision” filed in this appellate proceeding by the American Academy of Matrimonial Lawyers (the “AAML”) on May 2, 2022. The FLS concurs with the positions which the AAML has set forth in its amicus brief. In particular, the FLS concurs with the position that federal law does not preempt the authority of state courts to enforce divorce decrees entered by agreement of a military member and the former spouse. As set forth in the AAML’s amicus brief, when a veteran has contractually agreed to indemnify a former spouse for losses caused by the

veteran's voluntary waiver of retired pay in favor of disability compensation, state courts have the power to compel indemnification. The FLS, therefore, respectfully submits this joinder in the AAML's amicus brief.
