16	Appellant Ronald J. Robinson, by and through his attorney, the Law Offices	
17	of Michael F. Bohn, Esq., Ltd. moves this court to stay briefing on this case while post	
18	trial motions are being considered by the district court. This motion is based on the	
19	points and authorities contained herein.	
20	POINTS AND AUTHORITIES	
21	The district court entered judgment in this case on August 21, 2020, and	
22	notice of entry of judgment was entered on the same date.	
23	Prior counsel for Ronald Robinson, Harold P. Gewerter, filed the notice of	
24	appeal on September 21, 2020.	
25	However, co-defendant Vernon Rodriguez filed three post judgment motions	
26	before the district court on September 16, 2020. The first motion was for	
27	additional findings of fact and conclusions of law and to amend the judgment	

pursuant to NRCP 52(b). The second motion was for a new trial pursuant to NRCP

59(a). The third motion was a motion to stay execution. These motions are not scheduled to be heard by the district court until March 9, 2021.

NRAP 4(a)(4) provides that the time to file a notice of appeal is tolled for any motion filed under Rule52(b) to amend or make additional findings, or a motion for new trial under Rule 59.

This court issued an order on December 10, 2020 removing Harold P. Gewerter as attorney from this case has he has been suspended from the practice of law. The order also directed the appellant to retain counsel and file a notice of appearance within 45 days.

Michael F. Bohn, Esq. filed a notice of appearance in this case on February 3, 2021, admittedly past the 45 day deadline.

The December 10, 2020 order also suspended deadlines to file documents in this appeal pending further order of this court.

On February 8, 2021, this court entered an order reinstating briefing, requiring the appellant to file the opening brief and appendix within 90 days.

Appellant now moves for an order from this court to stay all matters involved in this case, including briefing until such time as the district court makes determinations on the post trial motions. It is anticipated that the remaining parties will be filing an appeal. The briefing for all parties appealing the district court's order can be done at the same time.

Appellant also respectfully submits that this appeal should be stayed instead of dismissed. No party will be prejudiced by a stay, and a dismissal will require appellant to incur additional filing fees.
