10 MICHAEL F. BOHN, ESQ. states:

12 1. Declarant is the attorney for the appellant in this case and makes this
13 declaration based upon personal knowledge.

15 2. This court issued an order to show cause on March 8, 2021, which pointed out
16 a number of potential jurisdictional defects.

18 3. A response to the order to show cause was submitted to this court on April 7,
19 2021, acknowledging the jurisdictional defects, and advising this court that a motion for
20 Rule 54(b) certification has been filed with the district court, and requested additional
21 time to file a supplemental response to the Order to Show Cause

24 4. On April 13, 2021, this court entered an order giving appellant until May 7,
25 2021 to file an amended docketing statement and a supplemental response to the order to
26 show cause.

5. On April 27, 2021, the district court heard appellant's motion for Rule 54(b) certification, and the motion was granted. A written order has not been entered as of this writing.

6. In reviewing the file to prepare the supplemental response, counsel has determined that because of the multiple jurisdictional defects with this appeal, it would be simpler for this appeal to be dismissed, and for appellant to timely file a new appeal after the Rule 54(b) order was entered.

7. Based on the foregoing, counsel for appellant consents to a dismissal of this appeal.
