APPELLANT'S MOTION TO EXTEND TIME TO FILE OPENING BRIEF
(FIRST REQUEST)

Appellant, Brian C. Padgett, in proper person, hereby respectfully moves this Court for a 30 day extension of time to and including December 9, 2020 to file his Opening Brief. The brief is currently due November 9, 2020. There have been no previous extensions sought in this matter. This motion is made pursuant to NRAP 27 and 31.

MEMORANDUM OF POINTS AND AUTHORITIES

a. Facts

This is an appeal taken from the Findings of Fact and Conclusions of Law made by a hearing panel appointed by the State Bar of Nevada and without the presence or knowledge of Appellant. The Issued Notice of Briefing Schedule/Bar Discipline was filed by the Supreme Court of Nevada on October 9, 2020 and at that time the Court issued an Order that Appellant file his Opening Brief on November 9, 2020.

Appellant had been ill for a majority of the week of November 1, 2020 and has been unable to timely complete the Appellant's Opening Brief as planned. This is Appellant's first request for extension. While Appellant has doctor appointments related to this illness on November 11, 2020 and November 16, 2020, Appellant does not need any more time than 30 days to finish the Opening Brief and deliver it to the Court.

b. Law

NRAP 27 and NRAP 31(b)(3) permit a party to file a motion to seek an extension of time to file a brief. This motion satisfies the requirements of NRAP 27 and 31(b)(3).

Appellant's Opening Brief is currently due November 9, 2020. This is the first request made for an extension of time to file this brief. Good cause exists as Appellant has been ill the week of November 1, 2020 and has not had sufficient time to complete Appellant's Opening Brief as a result thereof.

c. Summary

Appellant respectfully requests that his Court grant this first extension request and extend the time to file the opening brief to December 9, 2020.


