APPELLANT'S MOTION TO EXTEND TIME TO FILE OPENING BRIEF
(FIFTH REQUEST)

Appellant, Brian C. Padgett, in proper person, hereby respectfully moves this Court for a 1 day extension of time to and including January 12, 2021 to file his Opening Brief. The brief is currently due January 11, 2021. This motion is made pursuant to NRAP 27 and 31.

MEMORANDUM OF POINTS AND AUTHORITIES

a. Facts

This is an appeal taken from the Findings of Fact and Conclusions of Law made by a hearing panel appointed by the State Bar of Nevada and without the presence or knowledge of Appellant. The issued Notice of Briefing Schedule/Bar Discipline was filed by the Supreme Court of Nevada on October 9, 2020 and at that time the Court issued an Order that Appellant file his Opening Brief on November 9, 2020.

Appellant had been ill for a majority of the week of November 1, 2020 and had been unable to timely complete the Appellant's Opening Brief as planned and sought a first extension of time (30 days) to file the Opening Brief until December 9, 2020. This request was granted by the Court.

Thereafter, Appellant had not recovered from the illness as expected and had scheduled another doctor appointment on December 10, 2020. Appellant then sought a 14 day extension of time to file the Opening Brief until December 23, 2020. This request was granted by the Court.

Since that time, Appellant's medical appointment with his oncologist at Comprehensive Cancer Centers of Nevada was rescheduled at the last minute by

the oncologist and reset for January 5, 2021. As a result, Appellant has been unable to take as many steps in recovery from his health challenge as expected. Appellant then came before the Court and requested a 16 day extension of time to complete the Opening Brief and deliver it to the Court on or before January 8, 2021. This request was granted by the Court.

Following the January 5, 2021 appointment with his oncologist, Appellant had a significant, allergic reaction to one of his medications and is just now back in the office. Appellant then came before the Court and requested a 3 day extension of time to complete the Opening Brief and deliver it to the Court on or before January 11, 2021. This request was granted by the Court.

Finally, Appellant came before the Court and requested a 1 day extension of time to complete the Opening Brief and deliver it to the Court on or before January 12, 2021.

b. Law

NRAP 27 and NRAP 31(b)(3) permit a party to file a motion to seek an extension of time to file a brief. This motion satisfies the requirements of NRAP 27 and 31(b)(3).

Appellant's Opening Brief is currently due January 11, 2021. Good cause

exists for Appellant to be granted a final extension of time until January 12, 2021 as set forth above.


c. Summary


