**RESPONDENT TRYKE COMPANIES SO NV, LLC'S
UNOPPOSED MOTION FOR EXTENSION OF TIME TO FILE
RESPONDENT'S ANSWERING BRIEF
(Second Request for Extension of Answering Brief Deadline)**

Pursuant to Nevada Rules of Appellate Procedure ("NRAP") 27 and 31(b)(3), Respondent Tryke Companies SO NV, LLC ("Tryke"), by and through counsel of record, respectfully moves for a seven-day extension of time to file its answering brief in this appeal.

Tryke's answering brief is currently due **May 17, 2021**. By this motion, Tryke only seeks to extend the deadline to **May 24, 2021**.

Tryke has made one prior written request for an extension of the deadline for its answering brief. On April 21, 2021, counsel for Tryke and Appellant MM Development Company, Inc. dba Planet 13 ("Planet 13") filed a Stipulation for Extension of Time to File Respondent's Answering Brief, agreeing to a three-week

extension of the original deadline from April 26, 2020¹ to May 17, 2021. On April 22, 2021, this Court issued the Notice Motion/Stipulation Approved granting the parties' stipulation.

Tryke's counsel has discussed the requested seven-day extension of the answering brief deadline with Planet 13's counsel, and counsel has agreed to the requested courtesy. As such, Tryke submits the present request as an unopposed motion.

The presently requested extension is necessary due to previously unanticipated issues in the schedules of Tryke's counsel which will make completing and filing the answering brief by the current deadline exceedingly
