12 MS. TRUJILLO: As you know by my email, I'm requesting that
13 the Court set the sentencing between September 15th and 18th. My
14 client's mother has also rescheduled traveling here. Obviously through
15 -- it's -- all of this is out of everyone's control. We've rescheduled
16 sentencing several times. Most recently it was because there was a
17 new report that was available.

18 I understand that she's not going to get to speak; however, my
19 client is facing a significant amount of time. I think he should be able to
20 have a person here to support him during that time. He hasn't seen his
21 mother since December, which was the trial date. I'm only asking for a
22 few weeks and we continued this sentencing for months. I would ask for
23 a courtesy from both the Court and the State for that request.

24 And additionally, the report is still with my expert. I'm waiting
25 on him to respond to certain questions, so I don't have final information

1 on whether or not we're doing anything else with that report.

2 THE COURT: Okay. Let me --

3 MR. GIORDANI: If I can jump in. In that case -- I didn't
4 realize they were still reviewing the report, so September will be fine.

5 THE COURT: Okay. And what date did you want in
6 September?

7 MS. TRUJILLO: Between the 15th and the 18th.

8 THE COURT: Okay. Theoretically, we're going back to our
9 regular schedule in September.

10 THE CLERK: Judge, do you want to do this on a special
11 setting?

12 THE COURT: Right. I was going to do it on a homicide
13 setting, which normally would be on a Wednesday. Maybe out of an
14 abundance of caution, we should do it on a Friday. That way if the
15 families traveled -- if we're still doing this, you know, BlueJeans, then at
16 least we've already got Friday afternoon setting.

17 Does that make sense?

18 MR. GIORDANI: Works for the State.

19 THE COURT: So then if we're back to normal and we just
20 show up on Friday and do the sentencing or if we're not back to normal,
21 then the defendants will have to appear as they're appearing now from
22 the jail and we'll just handle it that way. So I would suggest a Friday in
23 September or what -- in the parameters of the dates Ms. Trujillo gave.

24 THE CLERK: Do you want to set it 3:30 or do you want to set
25 it in the morning?

1 THE COURT: Let's set it in the morning and then if we're not
2 back to normal, we'll move it to the afternoon, but at least the speakers
3 and the families will all be here on that Friday.

4 THE CLERK: Would you like that at 9:00 a.m.?

5 THE COURT: No -- sure, why not, 9:00 a.m.

6 THE CLERK: September 18th at 9:00 a.m.

13 MS. TRUJILLO: Thank you.


