## **MEMORANDUM**

I, KAREN MISHLER, am a duly licensed attorney in the State of Nevada and am employed by the Clark County District Attorney's Office.

This is the State's first request for an enlargement of time. If granted, the new filing date for Respondent's Answering Brief would be on or before Wednesday, September 8, 2021.

Brown filed his Opening Brief on July 8, 2021, after this Court granted his two Motions to Extend Time. Brown's Opening Brief raises four issues with several sub-issues and includes an eighteen-volume appendix.
