17 for Stay which exceeds the NRAP 27 (d)(2) page limit of 30 pages.

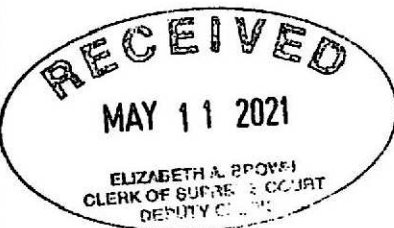

DECLARATION OF ALI SHAHROKHI

I ALI SHAHROKHI declare under penalty of perjury

(1) My child custody/paternity case has a record of approximately 4,000 pages. I have had no visitation with my son in 22 months. My case involves multiple writs where one, the orders were remanded and the judge never followed the writ, which is why I still have not seen my son on over 600 days and have not been afforded even one visitation with him.

(2) On August 6, 2019 an attorney, I hired, Bruce Shapiro, Esq., who filed a Petition for writ of mandamus. That petition was 60 pages long, encompassing 8 months of proceedings. That was over a year ago and the issues have continued to be even more extensive and, the errors have multiplied in the 18 months since that petition was filed.

(3) I am in proper person, and I'm not an attorney, neither is my native language English. What took 60 pages for Bruce Shapiro would likely have taken me 80 pages, yet this court accepted the 60 page petition for writ from a licensed Nevada attorney, I hope I am not discriminated against for being in proper person regarding the exhaustive amount of information that must be reviewed by this court.

1 (4) Additionally, my brief combines two separate appeals,
2 one from the three day trial commencing on 9/21/2020 and the
3 other appeal was a post judgement motion.

4 (5) Moreover, I was tried for crimes, in civil proceedings.
5 This was what took me so long to research and understand. The
6 issues in this case are egregious and my rights to parent were
7 stripped without following procedures in NRS 128. My son was
8 relocated 1,000 miles away where the court of appeals found
9 that my due process was violated.

10 (6) I tried my very best to keep the brief as short as I could
11 and I still fear I didn't get enough information before the court.

12 (7) My Appellate brief is 92 pages long. It's like a book. I
13 wish it wasn't so long and again, I fear everything wasn't
14 covered in getting me the relief I need.

15 (8) I have tried to conform to your requirements, please
16 forgive me if I did not meet your standards. I did my very best.
17 For my son.

18 (9) I do believe, considering an attorney needed 60 pages
19 to cover 8 months of proceedings, that my request for an
20 additional 32 pages (from what the attorneys needed) to cover 22
21 months of proceedings is a reasonable request. I come to you in
22 good faith and in hope for relief desperately needed.

1 (10) I ask for this court to grant me the additional 62 pages
2 needed, where the total length of my brief is 92 pages. If my
3 request for additional pages is not granted then I ask sufficient
4 time to re-write the fast track brief in 30 days.
