

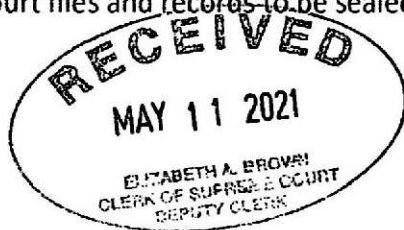

**"MOTION TO SEAL FAST TRACK STATEMENT"**
