**JUDICIAL NOTICE OF JURISDICTIONAL CHALLENGE**

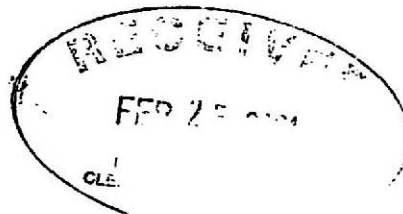

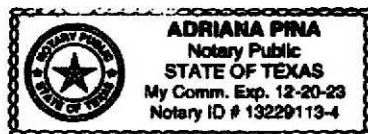
