Respondents State of Nevada ex rel. Department of Taxation and Cannabis Compliance Board (collectively, the "Department") move this Court, pursuant to NRAP 26(b)(1)(A) and NRAP 31(b)(3), for a 7-day extension, from the current due date of March 22, 2022 to March 29, 2022 to file its Answering Briefs. responsibility for drafting the Department's answering brief. The illness

affecting Ms. Levin has resulted in the necessity of this request.

Undersigned counsel has conferred with counsel for all Appellants.

There is no opposition to this request.

B. The 7-day extension should apply to all respondents

Several parties were allowed to intervene below, participated in the

proceedings, and were named by various appellants as party defendants

in their complaints. Although the opening briefs do not formally name

the intervenors/defendants as respondents and they are not identified in

the caption, the Department assumes, and hereby requests, that any

extension granted by this Court equally applies to them.

II. CONCLUSION

For these reasons, respondents respectfully request a 7-day

extension.
