ORDER REINSTASTING BRIEFING

On June 8, 2022, this court entered an order granting the motion of Integral Associates, LLC d/b/a Essence Cannabis Dispensaries; Essence Tropicana, LLC; and Essence Henderson, LLC (the Essence Entities) to be added to this appeal as respondents and directing the parties to file supplemental briefing on the jurisdictional issues raised by the Essence Entities in their motion to stay briefing or dismiss the appeal. The parties have filed their supplemental responses.

In its order, this court directed the parties to "bring to this court's attention any stipulation or certification that has subsequently been

filed in the district court that may resolve any potential jurisdictional issues." Pursuant to that directive, the Essence Entities filed a motion to certify the orders appealed from as final under NRCP 54(b). The merits briefing is reinstated as follows. The Essence Entities shall have 21 days from the date of this order to file and serve an answering brief. Thereafter, briefing shall proceed in accordance with NRAP 31(a)(1).
