## EMERGENCY REQUEST

TO ENLARGE AND DIVIDE ARGUMENT TIME AMONG RESPONDENTS

JUNE 5, 2023 ORAL ARGUMENT

Respondent/Cross-Appellant the State of Nevada *ex rel*.

Department of Taxation and Cannabis Compliance Board (the "State"), respectfully requests that this Court enlarge the time for argument. The State requests an additional five minutes of argument time in addition

to the 15 minutes already allotted to it and Respondents, the Essence Entities¹ and Lone Mountain Partners, LLC (collectively, the "Successful Applicant Respondents").² The State and the Successful Applicant Respondents would then split the 20 minutes of argument time evenly. As explained below, the State believes that this case warrants the extra time so that the State can address this Court's questions on issues particular to its involvement in the cannabis licensing process at issue here. The State does not object if Appellants/Cross-Respondents request an additional five minutes of argument time to balance the sides' arguments.

The Successful Applicant Respondents and the State are aligned but will present distinct viewpoints. The Successful Applicant Respondents focused their answering briefs on the threshold issue of standing, which is why the State suggests that their argument go first. The Successful Applicant Respondents can also discuss their own

experiences as applicants and the blossoming of the cannabis industry four years after the application process. The State, on the other hand, is principally concerned with the integrity and fairness of the application process as an administrative matter. And the State – unlike the Successful Applicant Respondents – cross-appealed and will present arguments supporting its cross-appeal.

This is a complicated case warranting enlarged and divided time. It arises from eight consolidated cases involving dozens of parties. Plaintiffs' joint appendix comprises 343 volumes; the State filed a three-volume supplemental appendix and the Essence Entities filed a 16-volume one. The parties to this appeal filed three opening briefs, four answering briefs, and three reply briefs addressing numerous different issues.

The State therefore requests that this Court divide Respondents' arguments as follows:

- 1. The Successful Applicant Respondents 10 minutes;
- 2. The State -10 minutes.
