REPLY TO MOTION TO REQUIRE APPELLANT TO PROVIDE TRANSCRIPT OF PROCEEDINGS

Respondent, Amanda Hogan ("Mother"), by and through counsel, Roderic A. Carucci, Esq. and the law firm of Carucci and Associates, replies to appellant, Anthony Monahan's ("Father"), opposition to her motion to require Father to provide the entire transcript of the hearing held on September 15, 2020. Mother has made inquiry of the Court Reporter, Capitol Reporting, Carson City, who advised that the cost of the transcript is \$1,600. Capitol Reporting prepared the mere 15 pages of the partial transcript requested by appellant to support his argument.

NRAP 9(a)(4) is clear on its face and provides in relevant part:

Number of Copies of Transcript; Costs. Appellant shall provide a copy of the certified transcript to counsel for each party appearing separately. Unless otherwise ordered, the appellant initially shall pay any costs associated with the preparation and delivery of the transcript.

It appears that appellant is attempting to shift the burden and expense of this appeal to respondent in order to avoid his legal responsibilities as required by the Nevada Rules of Appellate Procedure. As this is a matter subject to expedited fast track review, it is appropriate that this Court require appellant to provide the entire transcript of the approximately 3 hour hearing to respondent within 5 days as respondent's fast track statement is due on March 1, 2021. It is also appropriate that the Court award attorney's fees to respondent for having to demand production of a transcript that is required by the Rules.
