STATEMENT OF THE CASE

The State filed a Notice of Appeal from the district court's decision and order of dismissal of Mr. Manson's case (C-18-335833-1). The appeal was docketed in the Nevada Supreme Court on November 5, 2020.

The State's request for a 60-day extension to file their Opening Brief and Appendix was granted by this Court. The Opening Brief was filed May 4, 2021. Respondent's Answering Brief is due June 3, 2021.

Based on the reasons set forth in the Declaration of Counsel attached hereto, Mr. Manson is requesting 30 days to file his Answering Brief. This is his first Motion for an Extension.

POINTS AND AUTHORITIES

NRAP 31(b)(3)(B) sets forth in pertinent part:

A motion for extension of time for filing a brief may be made

no later than the due date for the brief.....

(B) ... The court will grant an initial motion for extension of time for filing a brief only upon a clear showing of good cause. The court shall not grant additional extensions of time except upon a showing of extraordinary circumstances and extreme need.

CONCLUSION

Mr. Manson moves this Court for a 30-day extension of time to file his Answering Brief, up to and including July 3, 2021.
