CIRCUMSTANCES OF ARREST:

Under event number 180401-1893 Kirra Clark, DOB, [REDACTED] called LVMPD dispatch to report that her missing thirteen year old daughter, [REDACTED] DOB [REDACTED] was at her residence located at [REDACTED] St., #12, LVN, 89169. The details stated [REDACTED] was at the residence with her 17 year old boyfriend, Tariq Mason, [REDACTED].

Officer A. Ryndak, P#16540 was dispatched to the family disturbance at [REDACTED] St. #12, LVN, 89169. Upon arrival Officer Ryndak made contact with Kirra. Kirra told Officer Ryndak that Tariq who is actually eighteen years old was having sex with her thirteen year old daughter [REDACTED]. [REDACTED] told Officer Ryndak that Tariq was her boyfriend and that the two have had sex. Tariq also told Officer Ryndak that he was having sex with [REDACTED].

Tariq was taken into custody and Officer Ryndak contacted Detectives.

I, Det. K. McCaffery, P#8731 along with Det. Brewer, P#7426 responded to [REDACTED] Street.

Interview with [REDACTED]

I along with Det. Brewer conducted a taped interview with [REDACTED]. The following is a brief synopsis of the interview and is not verbatim. [REDACTED] said she met Tariq on Facebook and the two started to exchange messages in September 2017. [REDACTED] stated Tariq knew she was thirteen and he told her she was seventeen when they were communicating on Facebook. In December 2017 Tariq came to [REDACTED] house and they watched a movie. [REDACTED] said in January 2018 the two had kissed for the first time and started dating.

On 02/06/18 at approximately 2300 hours [REDACTED] stated she was at Tariq's residence which is located at [REDACTED] B44, LVN, 89169. The two smoked marijuana and were very high. They went into the bathroom and began to kiss. Tariq took her clothes off and she took off his clothes. Tariq then put his penis in her vagina. [REDACTED] said that Tariq didn't use a condom and ejaculated in her vagina. On 03/30/18 while at Tariq's apartment the two had sex again. [REDACTED] stated everything pretty much happened the same way. Tariq again

didn't use a condom and ejaculated in her vagina. [REDACTED] had showered twice since then and refused to go get an exam. [REDACTED] said the two only had sex two times and it was consensual.

[REDACTED] stated her mother was aware of the relationship between her and Tariq. In February [REDACTED] said she had told her mother the two had sex.

Interview with Kirra Clark:

I along with Det. Brewer conducted a taped interview with Kirra. The following is a brief synopsis of the interview and is not verbatim. Kirra stated [REDACTED] showed up at her apartment today with Tariq and wanted money. Kirra said she had told [REDACTED] and Tariq she didn't want the two to hang out anymore after they had told her the two had sex and didn't use a condom. Kirra had [REDACTED] take a pregnancy test which came back negative. Kirra told them if they continued to hang out she was going to call the police so she did. Kirra said that Tariq had told her he was sixteen and wanted to have a baby with Tatianna. Kirra said [REDACTED] is a continual runaway. When she runs away she goes and stays at Tariq's for weeks at a time before she returns home.

Interview with Tariq Manson:

I along with Det. Brewer conducted a taped interview with Tariq at LVMPD Headquarters. The following is a brief synopsis of the interview and is not verbatim. I read Tariq his Miranda rights in which he acknowledged and stated he understood. Tariq agreed to talk to Detectives.

Tariq stated he met [REDACTED] through Facebook in December 2017. The two would message each other on Facebook. Tariq said he had been dating [REDACTED] for about three months and the two have had sex twice. Tariq stated the two times they had sex were at his apartment where he lives with his parents and little brother.

Tariq said the first time they had sex was about a month ago. No one was home and the two smoked marijuana. They were on the couch in the living room and the two started to rub on each other. Tariq said [REDACTED] rubbed on his stomach then went in his pants and rubbed on his penis. Tariq said he was wearing sweat pants and [REDACTED] was wearing jeans. [REDACTED] started to masturbate Tariq. Tariq started to rub on her bare breasts and kissed her neck and lips. [REDACTED] told him she was horny. [REDACTED] pulled her pants and underwear down to just above her knees. She took his pants to below his knee caps. [REDACTED] told Tariq he could put his penis in her vagina if he wanted to. Tariq put his penis in her vagina as she laid on her back. After about five minutes [REDACTED] turned around and Tariq put his penis in her vagina as he was behind her. He stopped when he ejaculated and got a cramp in his leg. Tariq said he pulled out and ejaculated on her buttocks.

Tariq said the last time they had sex was two days ago at his apartment. [REDACTED] told him she was horny and they went into the bathroom. Tariq's little brother (9 YOA) was home but was in the room. While in the bathroom the two started to kiss and Tariq rubbed on [REDACTED] vagina. Tariq said he pulled down [REDACTED] shorts to about her knee caps. She pulled his pants and underwear down to his ankles. Tariq said he put his penis in her vagina from behind as she was leaning on the counter. After about ten minutes Tariq stopped because he cramped up in his stomach and he ejaculated inside her vagina.

Tariq stated [REDACTED] didn't want to use a condom and the two wanted to have a baby together. [REDACTED] had told him last Tuesday that she was pregnant.

Tariq said he is eighteen years old and knew [REDACTED] was thirteen. Tariq said Kirra asked him if he had sex with [REDACTED] without a condom and he told her yes. Kirra told Tariq that his mother and she are going to have to fight. Tariq said Kirra had also text him on his phone that if he continues to be around [REDACTED] she would call the police. Tariq said that [REDACTED] had stayed at his house after she had told him that her mother kicked her out. Tariq said his parents agreed to let her stay there. She stayed about five days and the two slept in a bed together.

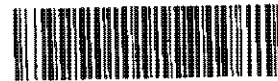
