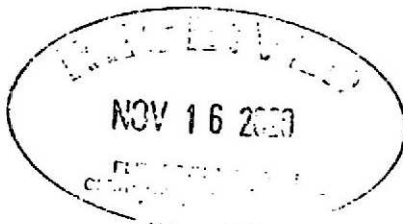
Petitioner, Katherine Fletcher, pursuant to NRS 34.750
