- 18 | the street from Fletcher's house where I conducted my
- 19 surveillance.
- 20 Q. And specifically where across the street were you?
- 21 A. Directly across the street in her neighbor's
- 22 driveway. I believe it's 3430 War Paint Circle.
- Q. At what time did you begin that surveillance?
- A. At approximately 2100 hours. That's 9:00 at

1 night. 2 Q. What did you see? 3 As I spoke with the neighbors briefly, went to ask 4 permission to park my unmarked vehicle in their driveway, 5 they stated I was welcome to park there any time and that Ms. Fletcher's vehicle, the one she normally drove, was a 6 7 dark blue Dodge Neon, which was pointed out in the driveway at the time I started my surveillance. 8 9 You saw the Neon at the house? Ο. 10 Α. I did. 11 Where was it? Q. 12 It was parked in the driveway of Ms. Fletcher's Α. 13 house. 14 MR. STEGE: May I approach the witness? 15 THE COURT: You may. Please approach freely. 16 BY MR. Then I noticed that Fletcher was in a bathing suit as she was walking back and forth through the house.
 - Q. What kind of a bathing suit?

- A. I'm not sure of the kind.
- Q. Well, as I recall there may be one-piece and two-piece?
 - A. It was a two-piece bathing suit.
 - O. What did she do in there?
- A. She paced back and forth for approximately

 30 minutes in the bathing suit talking to a younger boy,

 which I believe was her son, and her mother in her house

 before going to the far west end of the residence where she

 was out of my sight for approximately 30 minutes. And then

 she returned without the bathing suit on. It was a gray

 shirt and gray sweats I believe she was wearing at that time.
- Q. Anything else change about her appearance when she came back?

- A. After she changed her clothes, she came back out, it appeared her hair was wet like she had just taken a shower.
 - Q. And then what happened?
- A. Her and her son went outside over to this area is a chicken coop on the outside of the house where they were out there for approximately 30 minutes before returning back into the residence.
 - O. Then what?

- A. Approximately that time, it was around 2300 hours, which is 11:00, Fletcher is back in the living room with her mother. Through the big glass windows, I could see they were watching the 11:00 news. At which time, the breaking news story of the crime had come on and Fletcher appeared panicked and pointing to her mom at the story on the TV that I could see through the window.
 - Q. Please continue.
- A. After a few minutes of talking with her mom and they both seemed panic and pointing at the TV in a panicked manner, as I would describe it, Fletcher comes outside and gets into the Dodge Neon and leaves the residence west towards North Valleys High School.
 - Q. What do you do?
 - A. I follow her out. I call out to the rest of the

- detectives that are in the area in unmarked cars and we conducted a traffic stop on Fletcher in the area of North Valleys High School.
- Q. Is the area of the car stop depicted in page two of this exhibit?
 - A. Yes, it is.

We went out to the North Valleys and conducted a stationary surveillance out in that area.
- Q. And Officer Gott has indicated he was directly across the street from the War Paint address. Where were you?
- A. I was down closer to the high school, North
 Valleys High School, not too far from the address where Gott
 was sitting.
 - Q. And what else did you do?
- A. Just sat and just waited. We were waiting for the vehicle to leave to see if Ms. Fletcher would be in that vehicle. We had not confirmed license plates on the vehicle that was given to us that was at the original scene.

As Officer Gott was sitting across the street, he would update the team via our radio as far as movements and what was happening. At a certain point, he advised that the vehicle was leaving. He believed that Ms. Fletcher was the sole occupant of that vehicle and rolling surveillance was conducted on the vehicle as it left the residence and began

- to travel westbound on -- I don't even remember the street in front of the high school. A traffic stop was conducted on that vehicle once the plates were confirmed that it did match
- 4 the vehicle that was said to be at the scene.
- 5 Q. And who was inside that vehicle?
- 6 A. Katherine Fletcher.
 - Q. Is Katherine Fletcher in the courtroom today?
- 8 A. Yes, sir, she is.
 - Q. Would you identify her, please?
- 10 A. She's wearing a black and purple top sitting to my
 11 right.

- Q. What was your role in this car stop and subsequent actions?
- A. I made contact with Ms. Fletcher, asked her to step out of the vehicle and I asked her to join me back by my vehicle. She agreed to do so. I conducted or asked her for a pat down search of her person to confirm there's no weapons on her. She consented to the pat down.
- And then once that was completed, we were sitting really close to the roadway, so I asked if she would join in

- me my vehicle and we would drive across the street and park
 in the high school. She agreed to do so. And we drove from
 the traffic stop to across the street, roughly maybe a
 hundred yards, and sat in the parking lot where it was off
 - Q. During your time with Ms. Fletcher, did she make any statements about where it was she was going?
 - A. She did. She had told me that she was just going down to the market or the store down the street, a gas station, I believe, to buy some cigarettes. I had cigarettes in my vehicle, so I gave her some of my cigarettes.
 - Q. Did she make any statements about -- related to calling the police?
 - A. Yeah. She said that she was just going to go pick up her cigarettes and then she was going to call the police department.
 - Q. And when was that in this interaction from the car stop to moving over to the high school parking lot?
 - A. As far as like time line when she was making that comment?
 - Q. Yes.

A. It was once we got over to the parking lot. There wasn't any words really exchanged that I can recall during the short ride across the street. But once we got across the

- street and out of the vehicle, she explained she was going to buy some cigarettes and then call the police.
 - Q. How would you describe her demeanor -- before we get to the high school, how would you describe her demeanor at the car stop?
 - A. It fluctuated. It was calm and then a little more elevated like she was upset. Kind of just, what's going on? Explain that some detectives wanted to talk to her. But fairly calm, actually.
 - Q. Given the circumstances?
- A. Correct.

- Q. And given -- how many police officers or police vehicles were involved in making this car stop?
- A. To be honest with you, I don't recall. At the time, I think we had eight or nine guys working that day and Gott remained on the residence, as far as I can recall.

 There's two or three cars there originally and then more. As the surveillance broke down, more units came over to the traffic stop. So there was several of us. I can remember three or four for sure.
- Q. And given sort of the nature of the investigation, would you expect to use more than -- or what number of police cars? How would that affect the number of police cars and officers?

A. Normally, it would be a large amount with our team. We didn't need that many.

- Q. So what happens there waiting in the parking lot of the high school?
- A. We're -- we had obviously notified the RHU detectives. They were already in route to come out to meet with us at our location. As I was giving Ms. Fletcher cigarettes, I asked if she would be willing to speak with detectives when they came up to our location. Also informed her that the detectives would like her to go down to the Reno Police Department for an interview. She agreed to do so.

I continued to allow her to smoke cigarettes. We were standing outside the vehicle. I explained she wasn't under arrest, but they did want to speak with her an incident that occurred earlier in the day, which she agreed to.

She made the utterance that her and her mom had watched the news and they don't believe it's him, but would not elaborate any further on what news she was watching or who him was.

- Q. And were you in the position to know details about the investigation?
- A. We had been briefed about the general idea of what had happened. We got a general brief. We didn't have a ton of details.

- Q. And, for example, did you inquire of her, hey, what happened at the park or based on what you --
 - A. I did not.
- Q. And why not?

I'm not yet deciding whether or not you could expand on Mr. Hensley's testimony if he were to appear in person, but the pointed response to my question is you would request both the material witness warrant and that he be declared unavailable at least at this time. MR. STEGE: At least at this time, of course, subject to the --THE COURT: Your response, please. MR. EDWARDS: You know, I don't represent

Mr. Hensley, your Honor, so his issues with the State and disobedience to a subpoena is his issue. I would agree that, and Mr. Stege has intimated this, if he is declared unavailable due to his disobedience of that subpoena, the only testimony under oath and subject to cross examination was that pretrial hearing. And so there won't be any additional evidence presented, just what was present to the Court at that time.

THE COURT: Well, I will issue a -- first,

If you have a warrant, I would welcome that. Otherwise, I'll ask you to promulgate such a warrant, please, Mr. Stege.

In addition, at this juncture, I gather,
Mr. Stege, and I'm asking, but you needn't reply if you don't
want to, that you don't intend to adduce Mr. Hensley's
testimony today or immediately.

- 12 Q. Who else?
- A. Investigators, Zeronowski and Ivers from the Washoe County Crime Lab.
- 15 Q. So you respond at about 2100 hours?

- A. Yes. Oxbow Park is at the very end of Dickerson
 Road. It's about the 3100 block of Dickerson Road. It's an
 observatory for wildlife and it's a rather large park. There
 is a rather large pavilion as you first come into the park on
 your right-hand side. And then as you go a little bit to

your left, which we call to the east, there's a dirt parking lot. And then from the dirt parking lot, it goes to a little walkway. The walkways goes from basically asphalt to concrete and then on to a composite wood decking platform.

From that wood decking platform, it actually buttons up next to the Truckee River. Next to that even further east is a chain link fence separating the park from a private residence.

Once you get to the wood decking, it actually goes and runs along with the river and going to the west and it's a wood decking section that goes several feet and then it goes to another deck section where people can observe wildlife.

And then there's another quite a few feet where it goes into a third composite deck section where you can observe wildlife and the Truckee River.

From that point, you can exit the composite decking area. You can actually walk on a dirt path. The dirt path will take you through parts of Oxbow Park, the actual park. It's a very forested, tree area with shrubs, et cetera, that also runs along the Truckee River.

And then as you get to about a hundred yards from that dirt path, there's a split kind of in the path. One path goes further to the west and runs along the Truckee

River for approximately a thousand yards and then to the right it actually brings you back around to the other side of Oxbow Park.

It's all dirt right there, a dirt path and it brings you up to the most western side of the park. And at the western side of the park, you have another observation deck that's on ground level. And then you have another one that's elevated to where you can look at the wildlife and what have you from there.

From there, you go underneath, there's a pathway that goes underneath. It brings you out to kind of a picnic area or a grass area. That grass area has some picnic tables, some other benches, et cetera. And as you're walking out, you're basically coming back full circle and looking at that pavilion that I talked about earlier.

There's also a chain link fence that's going to be on the left hand side or the most western side that goes all the way to the entrance of the park.

The center of the park itself, the place that you actually walk through, again, it's very forested, there's lots of trees, there's only the one pathway that goes all the way through and then there's the big grass area.

Q. And as it relates to this case, which area was of interest to you?

- A. The interesting part for me was the most southeast corner of the park, which was the very first area where the composite wood decking was.
- Q. This is where the gentleman had been found on the ground?
 - A. Yes.

- Q. And so what do you do? What do you do next?
- A. Because it's dark, I actually requested a tree, big lighting tree to come in from the City of Reno. So we requested extra lighting to come in. And then we began to photograph the area.

I requested that Investigator Zeronowski take photographs of the area. And then we decided to figure out how to mark each piece of evidence that we saw at that point. Initially, when we're looking at it, there are little paper tents and a lot of times officers as they respond to a violent crime where there's evidence or a robbery or anything like that, they'll use anything they can in the car to actually mark that piece of evidence. So that as detectives show up, we can kind of highlight the areas so we don't miss anything.

There were several of these paper tents that actually started on the southeast corner of the park from where the asphalt and the concrete came together and then all

- 1 the way through where the wood decking was inside of that
 2 first little enclosed decking area.
 - Q. I wonder if I might interrupt you and let's start further back at the parking lot. Tell us the condition of the parking lot or what -- anything going on in the parking lot?

As you got towards the middle of the little deck system, there was a half smoked Pall Mall cigarette. And just barely off to the right of that, just a little bit to the left of that was a spent nine-millimeter Ruger Hornady casing plus P.

- Q. And was it -- are you the only detective or law enforcement person looking in the park?
- A. I am at that time and I have Investigators

 Zeronowski and also Ivers with me. They're present, but I'm doing the majority of the searching. Yeah.

So, basically, there's a chain link fence that runs just as you come into the entrance of the park and it's on the east side and I followed that entirely all the way down until I actually hit the platform where the decedent's body was found and all of the evidence.

And then from there, I walked this path, and you can kind of see it right here, here and here, those are the three decking systems that go up next to the river and searched the sides of these as well.

Now, you can only such these from above, because at that time there was water kind of brushed up all underneath that. So with a flashlight, I went all the way down and then there's a pathway that starts right here and

that's that dirt pathway that starts and it comes kind of straight down here and it hooks back around on this other pathway, goes along the river and it goes about a thousand yards, it just goes and goes and goes.

So I searched this whole pathway all the way back until we hit the other decking system. And I'm trying to see if it's actually there and I don't see it. But there's a decking system that is right about here that is ground level and then there's another one that's elevated that's about right about here.

So this was all searched through here. And then as you walk back through, you're kind of pointing towards the pavilion again, which is here. Searched all of this forested area through here and this whole picnic area, which is all right through here. And then walked this west line, which is another chain link fence all the way back to the entrance.

- Q. That first chain link fence you described, can you indicate where that is, please?
- A. Yes. So as you come in, it is -- this is the parking area and it's connected back here and it goes all the way to kind of here and it actually attaches right here on that composite decking right there in the corner.
- Q. Now, having a shell casing so close to where the man went down, what was sort of the investigative

significance of that to you?

A. Said to me that the shooting was close. That we would have found a casing somewhere in the water or up in the shrubs or what have you had it occurred outside of that little pavilion area.

With the nine millimeter casing, the other thing that is of interest is when it gets ejected, it goes 5:00. So it won't hit you 6:00 right in the nose, but it goes 5:00. And then from there, it only travels anywhere between six and eight feet is the average for nine millimeter with the amount of gunpowder, et cetera.

- Q. So you said 5:00?
- 13 A. Uh-huh.
 - Q. That would be to the shooter's right?
- 15 A. Yes.
 - Q. Sort of back and to the right?
 - A. One other thing to take into consideration is you can't really say exactly which direction the shooter was facing. I've been on many crime scenes when I've believed a shooter had shot either, north, south, east or west and later found that the casing had been kicked, moved, et cetera. So to be able to say specifically the direction the shooter was facing, there's no way to tell that.
 - Q. Right. You don't know that. But you know if a

- casing is undisturbed might give you an idea of where the shooter was standing?
 - A. Yes, much more helpful.
 - Q. All right. Were you briefed or did you know whether police had control of the scene since arriving?
 - A. I did know that they had control of the scene. My only concern was that during the shooting, if anybody accidently kicked it or that was unknown so I couldn't tell exactly.
 - Q. This is part of the reason you searched through this whole park?
 - A. Correct.

- Q. And did you find anything of evidentiary value?
- A. No, not there.
- 15 Q. What is that terrain like?
 - A. It's very grassy. The parking area is very -it's like compacted sand and dirt and rock, like light rock.
 The pathways, there's really good pathways that are closest
 to the river, which are all composite wood. Then you go all
 dirt, everything is kind of a hard compacted trail, if you
 will, all the way around the rest of it.
 - THE COURT: Mr. Stege, bookmark your spot there, hard compacted trial. We're hard upon the lunch hour. Let's go ahead and take a recess. Ladies and gentlemen, for your

purposes, we'll be in recess until 1:30.

During this recess, it is your duty not to converse yourselves or with anyone else on any subject connected with this trial or to read, watch or listen to any report of or commentary on the trial by any person connected with the trial or by any medium of information, including, without limitation, newspaper, television, radio, Internet or smart phones. You're not to form or express an opinion on any subject connected with this case until it is finally submitted to you after the presentation of evidence and arguments of counsel are concluded. Again, ladies and gentlemen, we'll be in recess until 1:30.

(The following proceedings were had outside the presence of the jury.)

THE COURT: Gentleman, is there a need for a hearing at 1:00?

MR. EDWARDS: No.

MR. STEGE: No.

THE COURT: So I'll look to the two of you, then, to confer about the perimeters and/or admissibility or scope of admissibility of any written statements by Ms. Fletcher that were mentioned by Mr. Stege. Thank you.

(A lunch break was taken.)

THE COURT: Mr. Stege indicates to me that both of you are subpoenaed as witnesses in this case. I just had my clerk administer the oath of witnesses to both of you. It's a serious oath and I'd like to talk to you about things that you may not discuss during your testimony. Do you understand? I see you nodding your head yes. Ms. Jorgenson, do you understand as well, ma'am?

MS. JORGENSON: I will when you explain what it is.

THE COURT: Let me jump right to the point. The attorneys are going to ask you questions in front of the jury in this case. Please listen to the questions and answer only the questions asked.

Let me give you an example. Let's say this case were about something that it's not about, it's about something much more important than an auto accident, but let's say this case was about an auto accident and you were witnesses to the auto accident.

Let's just say the State were to ask you a question to the effect of: What color was the light before the cars entered the intersection and crashed? And you were to answer, well, I knew the first driver was at fault, because the first driver ran the red light and ran right into

the second driver without braking or any explanation. That answer is not responsive to the question. The question is:

What color is the light? So I want you to make sure that you listen carefully to the questions and answer only the questions which have been offered.

Let me be more particular in my cautions to the two of you. It's been represented to me by the attorneys, specifically by the State, that there are recordings of telephone conversations between either or both of you and your daughter while she's been in custody in this case. It's been further represented to me that your daughter has suggested in particular to you, Ms. Jorgenson, that you should volunteer certain information on the stand whether or not an attorney were to ask you about it.

If you do that, I want you to understand you could be in trouble with me and you'll be in violation of the order I'm about to give. The order I'm about to give is this:

There are subjects of conversation which you may not testify about unless one of the attorneys specifically asks you about it or I give you permission to talk about it.

For example, there have been a number of circumstances of Social Services or so-called Child Protective Service's involvement in your grandchildren's lives, in your lives and in your daughter's life. I direct

that neither of you talk about the CPS cases or those circumstances if and until I determine that they're relevant. So that means you may not volunteer any information or talk about that subject matter.

Neither of you may discuss the drug use or alleged drug use by Mr. Trask. Mr. Trask may or may not have used drugs. If he did or didn't use drugs, that is not relevant to this case. It is not information that the jury is allowed to hear in this case if and until I deem it to be relevant.

Finally, there are two other topics that I know must be of some concern, at least within your family unit, and that is allegations that I've been told about that your daughter's made that Mr. Trask physically abused her and allegations that your daughter's made that Mr. Trask sexually or physically abused Max. Neither of you may discuss those subjects either without my express permission. Those subjects generally are irrelevant to the issues at hand in this trial. Do you have any questions about my instructions to you, Mr. Jorgenson?

MR. JORGENSON: No.

THE COURT: Do you have any questions about my instructions to you, Ms. Jorgenson?

MS. JORGENSON: Well, one thing that you called an allegation is a fact.

THE COURT: Well, let us not argue, you and I. 1 2 MS. JORGENSON: Can I get my jacket. It's cold in 3 here. 4 THE COURT: No, ma'am. It's adequate to the task. If you're cold, I promise you you'll be able to step out and 5 6 get a jacket. 7 MS. JORGENSON: It's in the hall. Can one of them 8 bring it to me? 9 THE COURT: No, ma'am. Let's concentrate on the 10 conversation you and I are having now. I understand that you have close felt feelings about the truth of allegations, the 11 12 word I'm using allegations, related to sexual or physical 13 abuse. This trial isn't about those allegations. It's about something altogether different. 14 15 Do you have any questions about the instructions 16 I've given you. I know you disagree about whether or not 17 they're allegations, but do you have any questions. You're 18 shaking your head no. Is that a no? 19 MS. JORGENSON: It was a no. 20 THE COURT: I need you to answer out loud, I'm not 21 trying to be rude, only because the court reporter sitting 22 below me has to take everything someone communicates and she 23 has no way to record what a nod of the head is. So that's

the only reason I followed up on it.

Please understand I understand I can't imagine how difficult it is to be sitting where you're sitting in a case where a loved one is accused of a very serious crime. I'm not interested -- please just listen to my conversation.

MS. JORGENSON: I can't hear well. That's why I did this so you know I need you to speak louder, please.

THE COURT: All right. I, too, have a hearing loss and I'm speaking loudly and directly to you. That's why I had you brought into the jury box just a few feet away from me. I'm confident that I'm projecting and I'll continue to project.

I can only imagine how difficult it must be to sit where you're sitting with your daughter accused of what she's accused of. Please don't put me in the position of seeking or finding that either of you were in contempt of Court for following my order. That would, just so you know, be the worst possible thing you could do for your daughter.

If, for example, you were to volunteer information that is not relevant or that I would find to be not relevant and I had to caution you about it in front of the jury, that's the worst possible evidence you could give for your daughter. So please keep that in mind as you are called upon to testify here today. Do you have any questions, Mr. Jorgenson, about what I've indicated are the bounds or

limits of your testimony? 1 2 MR. JORGENSON: No. THE COURT: Do you have any questions, 3 4 Ms. Jorgenson? You're shaking your head no. Thank you for 5 that. Thank you for taking a few moments to speak with me. 6 Please, if you would step outside and Mr. Stege will call you 7 as he sees fit in this case. I appreciate you taking a 8 moment to talk with me. 9 MS. JORGENSON: Thank you, judge. 10 THE COURT: You're welcome. Thank you. 11 The Jorgensons are now outside of the courtroom. 12 Is there anything else you'd like to place on the record, 13 Mr. Stege? 14 MR. STEGE: Not on that issue. THE COURT: You seek to adduce those facts from Mr. and Ms. Jorgenson?

MR. STEGE: Yes. Going further, that gun was the gun used at my target shooting motion. Mrs. Jorgenson will affirm same gun as part of that. It was asked by Mrs. Jorgenson to keep the gun not in the house. She indicates she saw Fletcher put the gun in her car.

There was also probably separate discussion or statement by Mr. Jorgenson, oh, it's okay, she can keep it in her room. But it's really surrounding this possession of a

1 gun. 2 THE COURT: Okay. Any objection or objections, 3 Mr. Edwards? 4 MR. EDWARDS: Your Honor, this is the first time 5 I'm really hearing the scope of he says will be presented. I will simply say this: In contradistinction to my prior rulings about target shooting, for example, and possession of firearms, there are circumstances in which we know as a matter of an adjudicated fact that Ms. Fletcher was in possession of stolen firearms, because she's been adjudicated related to that incident and we're not discussing that.

The context, however, of our prior conversations about target shooting, clearing a jam and guns was this: At the time of those hearings, there was no factual connection or representation made to me about a nine millimeter handgun in Ms. Fletcher's possession. That has changed.

In other words, it's represented to me that now coordinate with this notice from Judge Lumkes about the loss of an administrative appeal within about a month or three weeks of that, Ms. Fletcher worked at a gun show, allegedly, and purchased a nine millimeter handgun, which Mr. Stege represents to me will be connected to target shooting with the handgun and/or clearing of a jam related to that handgun.

That's clearly probative evidence. It's clearly evidence which demonstrates opportunity to possess a firearm,

THE COURT: I understand completely.

MR. STEGE: I would add two things. First, a possible additional rationale under the guise of preparation, sort of our bad acts analysis. Second, looking at my notes here, I think page 65 of -- 4 or 5, Ms. Jorgenson's statement that three weeks to a month ago on the target shooting.

- 1 THE COURT: Thank you for answering with your
- 2 | voice. I appreciate it. The lady sitting in front of me has
- 3 to take down every word, so we have to answer with our voice
- 4 as you did. Thank you. Go ahead.
- 5 BY MR. STEGE:
- 6 Q. Do you remember the day that your daughter got
- 7 | arrested in July of 2016?
- 8 A. Yes.
- 9 Q. I want to talk to you about that day.
- 10 A. About what?
- 11 Q. What happened that day. When she left -- well, do
- 12 you remember her leaving your house?
