UNOPPOSED MOTOSPOTEME Court EXTEND TIME TO FILE APPELLANT'S OPENING BRIEF (SECOND REQUEST)

Appellant SFR Investments Pool 1, LLC ("SFR") respectfully requests an additional thirty (30) days, up to and including **Wednesday**, **July 28**, **2021**, in which to file its opening brief. NRAP 26(b)(1). The brief is currently due on June 28, 2021, pursuant to this Court's June 2, 2021 Order granting the parties' stipulation to extend the time for SFR to file its opening brief. This is the second request to extend time for this brief.

SFR has been diligently working on the brief. However, several of SFR's attorneys have been out of the office recently due to personal and medical issues, and that a number of employees have recently left the firm, has required reassignment of tasks and interfered with SFR's ability to properly complete the opening brief by the current deadline. In addition to the good cause already demonstrated, and noting that this Court has previously denied a stay based on

Collins v. Yellen, 19-422, on June 23, 2021, the Supreme Court of the United States of America issued its opinion in Collins, holding that HERA's restriction on the removal power is unconstitutional (pp. 17-36). While it did not conclude that all acts taken by the Director under the unconstitutional provision were void ultra vires, the Supreme Court did remand for the district court to determine in the first instance if the unconstitutional provision caused any harm to the petitioners (p. 36). The additional time will allow SFR the time to address Collin's in its opening brief as this case involves Fannie Mae, FHFA's decisions, and HERA.

Notwithstanding the foregoing, SFR respectfully submits that it does not anticipate that any further extensions will be requested by SFR in connection with the submission of its opening brief.

Counsel for SFR contacted Melanie D. Morgan, Esq., counsel for Respondent Nationstar Mortgage LLC ("Nationstar"), and informed her of the instant request for extension of time. Ms. Morgan indicated that she and Nationstar do not object to the requested extension.

For the reasons stated above, and Nationstar's agreement, this request is made in good faith and not intended for purposes of delay or prejudice to any party.
