Good cause exists to allow Akerman's withdrawal as a result of the discharge. RPC 1.16(a)(3). Withdrawal can be accomplished without material adverse effect to Nationstar since its appellate briefing is complete and Nationstar is retaining new counsel. Nationstar filed its answering brief on September 27, 2021. SFR's reply brief is due November 29, 2021. This motion is not meant to

delay adjudication of the appeal. Akerman does not anticipate any party will object to the withdrawal under the circumstances described herein.
